The Status of Women in Illinois, 2015: Highlights

Women in Illinois have made considerable advances in recent years but still face inequities that often prevent them from reaching their full potential. Since the 2004 *Status of Women in the States* report was published, the gender wage gap in Illinois has narrowed, a higher percentage of women have bachelor's degrees, and women are more likely to work in managerial or professional occupations. Yet, as in all other states, women in Illinois are less likely than men to be in the labor force and more likely to live in poverty. Women also continue to be underrepresented in the state legislature.

Key Findings

- Illinois's best grade is in the area of reproductive rights, for which it receives a B+. Its worst grades are in political participation and work and family, for which it gets a D+.
- Illinois women who work full-time, year-round earn 80 cents on the dollar compared with similarly employed men.
- Approximately 28.2 percent of those working in science, technology, engineering, and mathematics (STEM) fields in Illinois are women, compared with 28.8 percent nationwide.
- As of 2015, there is one woman of color in statewide elective executive office in Illinois, and only two women of color from the state in the U.S. Congress.

- Women in Illinois who are unionized earn \$122 more per week, on average, than those who are not represented by a union.
- Approximately 32.7 percent of women in Illinois have a bachelor's degree or higher, an increase of about 8 percentage points since 2000.
- In 2012–2013, 41.4 percent of Illinois's four-year-olds were enrolled in state pre-K, preschool special education, or state and federal Head Start.
- Heart disease is the biggest killer of women in the United States. Illinois ranks 29 of 51 with a mortality rate of 136.9 per 100,000.
