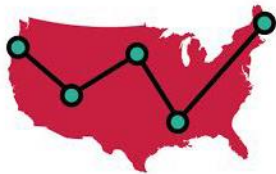

## The Status of Women in Indiana, 2015: Highlights

Women in Indiana have made considerable advances in recent years but still face inequities that often prevent them from reaching their full potential. Since the 2004 *Status of Women in the States* report was published, the gender wage gap in Indiana has narrowed, a higher percentage of women have bachelor's degrees, and women are more likely to work in managerial or professional occupations. Yet, as in all other states, women in Indiana are less likely than men to be in the labor force and more likely to live in poverty. Women also continue to be underrepresented in the state legislature.



If current trends continue, women in Indiana will not see equal pay until the year **2086**.\*



Women hold **20.7%** of seats in the state legislature.

### Key Findings

- Indiana's best grade is in the area of political participation, for which it receives a C-. Its worst grade is in work and family, for which it gets an F.
- Indiana women who work full-time, year-round earn 76 cents on the dollar compared with similarly employed men.
- Approximately 25.7 percent of those working in science, technology, engineering, and mathematics (STEM) fields in Indiana are women, compared with 28.8 percent nationwide.
- As of 2015, there are no women of color in statewide elective executive office in Indiana, and no women of color from the state in the U.S. Congress.
- Women in Indiana who are unionized earn \$247 more per week, on average, than those who are not represented by a union.
- Approximately 23.9 percent of women in Indiana have a bachelor's degree or higher, an increase of about 6 percentage points since 2000.
- In 2012–2013, 14.5 percent of Indiana's four-year-olds were enrolled in state pre-K, preschool special education, or state and federal Head Start.
- Heart disease is the biggest killer of women in the United States. Indiana ranks 38 of 51 with a mortality rate of 147.7 per 100,000.
