The Status of Women in Kansas, 2015: Highlights

Women in Kansas have made considerable advances in recent years but still face inequities that often prevent them from reaching their full potential. Since the 2004 *Status of Women in the States* report was published, the gender wage gap in Kansas has narrowed, a higher percentage of women have bachelor's degrees, and women are more likely to work in managerial or professional occupations. Yet, as in all other states, women in Kansas are less likely than men to be in the labor force and more likely to live in poverty. Women also continue to be underrepresented in the state legislature.

Key Findings

- Kansas's best grades are in the areas of employment and earnings, poverty and opportunity, and health and well-being, for which it receives a C+. Its worst grade is in reproductive rights, for which it gets an F.
- Kansas women who work full-time, year-round earn 78 cents on the dollar compared with similarly employed men.
- Approximately 28.7 percent of those working in science, technology, engineering, and mathematics (STEM) fields in Kansas are women, compared with 28.8 percent nationwide.
- As of 2015, there are no women of color in statewide elective executive office in Kansas, and no women of color from the state in the U.S. Congress.
- Women in Kansas who are unionized earn \$202 more per week, on average, than those who are not represented by a union.
- Approximately 31.2 percent of women in Kansas have a bachelor's degree or higher, an increase of about 7 percentage points since 2000.
- In 2012–2013, 36.2 percent of Kansas's four-year-olds were enrolled in state pre-K, preschool special education, or state and federal Head Start.
- Heart disease is the biggest killer of women in the United States. Kansas ranks 23 of 51 with a mortality rate of 124.5 per 100,000.
