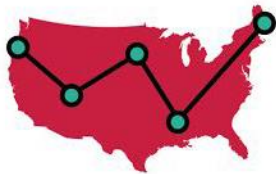

## The Status of Women in Maryland, 2015: Highlights

Women in Maryland have made considerable advances in recent years but still face inequities that often prevent them from reaching their full potential. Since the 2004 *Status of Women in the States* report was published, the gender wage gap in Maryland has narrowed, a higher percentage of women have bachelor's degrees, and women are more likely to work in managerial or professional occupations. Yet, as in all other states, women in Maryland are less likely than men to be in the labor force and more likely to live in poverty. Women also continue to be underrepresented in the state legislature.



If current trends continue, women in Maryland will not see equal pay until the year **2042**.\*



Women hold **31.4%** of seats in the state legislature.

### Key Findings

- Maryland's best grade is in the area of reproductive rights, for which it receives an A-. Its worst grade is in political participation, for which it gets a C-.
- Maryland women who work full-time, year-round earn 87 cents on the dollar compared with similarly employed men.
- Approximately 34.4 percent of those working in science, technology, engineering, and mathematics (STEM) fields in Maryland are women, compared with 28.8 percent nationwide.
- As of 2015, there are no women of color in statewide elective executive office in Maryland, and only one woman of color from the state in the U.S. Congress.
- Women in Maryland who are unionized earn \$234 more per week, on average, than those who are not represented by a union.
- Approximately 38.1 percent of women in Maryland have a bachelor's degree or higher, an increase of about 9 percentage points since 2000.
- In 2012–2013, 48.3 percent of Maryland's four-year-olds were enrolled in state pre-K, preschool special education, or state and federal Head Start.
- Heart disease is the biggest killer of women in the United States. Maryland ranks 33 of 51 with a mortality rate of 139.0 per 100,000.
