The Status of Women in Missouri, 2015: Highlights

Women in Missouri have made considerable advances in recent years but still face inequities that often prevent them from reaching their full potential. Since the 2004 *Status of Women in the States* report was published, the gender wage gap in Missouri has narrowed, a higher percentage of women have bachelor's degrees, and women are more likely to work in managerial or professional occupations. Yet, as in all other states, women in Missouri are less likely than men to be in the labor force and more likely to live in poverty. Women also continue to be underrepresented in the state legislature.

Key Findings

- Missouri's best grade is in the area of political participation, for which it receives a C. Its worst grades are in health and well-being and reproductive rights, for which it gets a D.
- Missouri women who work full-time, year-round earn 79 cents on the dollar compared with similarly employed men.
- Approximately 30.9 percent of those working in science, technology, engineering, and mathematics (STEM) fields in Missouri are women, compared with 28.8 percent nationwide.
- As of 2015, there are no women of color in statewide elective executive office in Missouri, and no women of color from the state in the U.S. Congress.

- Women in Missouri who are unionized earn \$187 more per week, on average, than those who are not represented by a union.
- Approximately 27.1 percent of women in Missouri have a bachelor's degree or higher, an increase of about 7 percentage points since 2000.
- In 2012–2013, 19.0 percent of Missouri's four-year-olds were enrolled in state pre-K, preschool special education, or state and federal Head Start.
- Heart disease is the biggest killer of women in the United States. Missouri ranks 41 of 51 with a mortality rate of 155.8 per 100,000.
