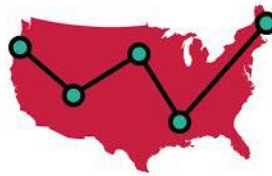

## The Status of Women in Oklahoma, 2015: Highlights

Women in Oklahoma have made considerable advances in recent years but still face inequities that often prevent them from reaching their full potential. Since the 2004 *Status of Women in the States* report was published, the gender wage gap in Oklahoma has narrowed, a higher percentage of women have bachelor's degrees, and women are more likely to work in managerial or professional occupations. Yet, as in all other states, women in Oklahoma are less likely than men to be in the labor force and more likely to live in poverty. Women also continue to be underrepresented in the state legislature.



If current trends continue, women in Oklahoma will not see equal pay until the year **2068**.\*



Women hold **12.8%** of seats in the state legislature.

### Key Findings

- Oklahoma's best grade is in the area of work and family, for which it receives a C+. Its worst grades are in poverty and opportunity and health and well-being, for which it gets a D-.
- Oklahoma women who work full-time, year-round earn 80 cents on the dollar compared with similarly employed men.
- Approximately 25.1 percent of those working in science, technology, engineering, and mathematics (STEM) fields in Oklahoma are women, compared with 28.8 percent nationwide.
- As of 2015, there are no women of color in statewide elective executive office in Oklahoma, and no women of color from the state in the U.S. Congress.
- Women in Oklahoma who are unionized earn \$106 more per week, on average, than those who are not represented by a union.
- Approximately 24.0 percent of women in Oklahoma have a bachelor's degree or higher, an increase of about 5 percentage points since 2000.
- In 2012–2013, 87.1 percent of Oklahoma's four-year-olds were enrolled in state pre-K, preschool special education, or state and federal Head Start.
- Heart disease is the biggest killer of women in the United States. Oklahoma ranks 49 of 51 with a mortality rate of 182.7 per 100,000.
