The Status of Women in Virginia, 2015: Highlights

Women in Virginia have made considerable advances in recent years but still face inequities that often prevent them from reaching their full potential. Since the 2004 *Status of Women in the States* report was published, the gender wage gap in Virginia has narrowed, a higher percentage of women have bachelor's degrees, and women are more likely to work in managerial or professional occupations. Yet, as in all other states, women in Virginia are less likely than men to be in the labor force and more likely to live in poverty. Women also continue to be underrepresented in the state legislature.

Key Findings

- Virginia's best grade is in the area of employment and earnings, for which it receives a B. Its worst grades are in political participation and work and family, for which it gets a D-.
- Virginia women who work full-time, year-round earn 79 cents on the dollar compared with similarly employed men.
- Approximately 29.6 percent of those working in science, technology, engineering, and mathematics (STEM) fields in Virginia are women, compared with 28.8 percent nationwide.
- As of 2015, there are no women of color in statewide elective executive office in Virginia, and no women of color from the state in the U.S. Congress.

- Women in Virginia who are unionized earn \$303 more per week, on average, than those who are not represented by a union.
- Approximately 35.8 percent of women in Virginia have a bachelor's degree or higher, an increase of about 8 percentage points since 2000.
- In 2012–2013, 26.5 percent of Virginia's four-year-olds were enrolled in state pre-K, preschool special education, or state and federal Head Start.
- Heart disease is the biggest killer of women in the United States. Virginia ranks 25 of 51 with a mortality rate of 128.3 per 100,000.
