The Economic Status of Women in New Mexico

Women in New Mexico have made considerable advances in recent years but still face inequities that often prevent them from reaching their full potential. Since the 2004 *Status of Women in the States* report was published, the gender wage gap in New Mexico has narrowed, a higher percentage of women have bachelor's degrees, and a larger share of women live in poverty. New Mexico still ranks in the worst third in the nation for both women's Employment & Earnings and Poverty & Opportunity.



Key Findings

- New Mexico's grade for women's Employment & Earnings, D+, has improved since the 2004 *Status of Women in the States* report (Table 1). Its grade for women's Poverty & Opportunity, D, has remained unchanged since 2004.
- Women in New Mexico aged 16 and older who work full-time, year-round have median annual earnings of \$35,000, which is 83.3 cents on the dollar compared with men who work full-time, year-round (Table 1). Native American women earn just 51 cents for every dollar earned by White men (Table 2).
- If employed women in New Mexico were paid the same as comparable men, their poverty rate would be reduced by more than half and poverty among employed single mothers would drop by half (Figure 1).³
- 54.7 percent of women in New Mexico aged 16 and older are in the labor force, compared with 62.5 percent of men (Table 1). Among women, Other Race or Multiracial women have the highest labor force participation rate, at 66.7 percent (Table 2).
- A growing share of employed women in New Mexico are in managerial or professional occupations. About 40 percent of women hold these positions, which tend to require a four-year degree and often have higher wages and employment benefits.
- In New Mexico, 39.0 percent of businesses in 2012 were owned by women, up from 31.7 percent in 2007.
- Approximately 28 percent of women aged 25 and older in New Mexico have a bachelor's degree or higher, an increase of about 6 percentage points since 2000 (Table 1).
- 89.6 percent of New Mexico's women aged 18 to 64 have health insurance coverage, which is above the national average for women of 89.4 percent (Table 1).
- New Mexico ranks 48th nationally for the share of women in poverty; 21.2 percent of women in the state aged 18 and older are in poverty, compared with 17.0 percent of New Mexico's men (Table 1).



Impact of Equal Pay on Working Women's Poverty in New Mexico, 2016: Current Values and Estimates if Working Women Earned the Same as Comparable Men





- 2. The 2015-16 average undergraduate tuition and required fees for in-state, full-time students in degree-granting public two-year institutions in New Mexico is \$1,553.
- 3. Comparable includes women and men of the same age and level of education, who work the same number of hours, and have the same urban/rural status.
