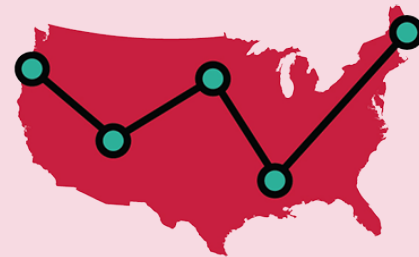

The Economic Status of Women in Utah

Women in Utah have made considerable advances in recent years but still face inequities that often prevent them from reaching their full potential. Since the 2004 *Status of Women in the States* report was published, the gender wage gap in Utah has widened, a higher percentage of women have bachelor's degrees, and a larger share of women live in poverty. Utah still ranks in the worst third in the nation for women's Employment & Earnings and in the middle third for Poverty & Opportunity.

Key Findings

- Utah's grade for women's Employment & Earnings, **D**, has remained the same since the 2004 *Status of Women in the States* report (Table 1). Its grade for women's Poverty & Opportunity, **D+**, has dropped since 2004.
- Women in Utah aged 16 and older who work full-time, year-round have median annual earnings of \$35,000, which is 70.0 cents on the dollar compared with men who work full-time, year-round (Table 1). Hispanic women earn just 47 cents for every dollar earned by White men (Table 2).
- If employed women in Utah were paid the same as comparable men, their poverty rate would be reduced by more than half and poverty among employed single mothers would drop by nearly half (Figure 1).³
- 59.8 percent of women in Utah aged 16 and older are in the labor force, compared with 76.2 percent of men (Table 1). Among women, Black women have the highest labor force participation rate, at 65.5 percent (Table 2).
- A growing share of employed women in Utah are in managerial or professional occupations. About 38 percent of women hold these positions, which tend to require a four-year degree and often have higher wages and employment benefits.
- In Utah, 30.3 percent of businesses in 2012 were owned by women, up from 25.0 percent in 2007.
- Approximately 30 percent of women aged 25 and older in Utah have a bachelor's degree or higher, an increase of about 8 percentage points since 2000 (Table 1).
- 89.5 percent of Utah's women aged 18 to 64 have health insurance coverage, which is above the national average for women of 89.4 percent (Table 1).
- Utah ranks 17th nationally for the share of women in poverty; 14.2 percent of women in the state aged 18 and older are in poverty, compared with 13.3 percent of Utah's men (Table 1).

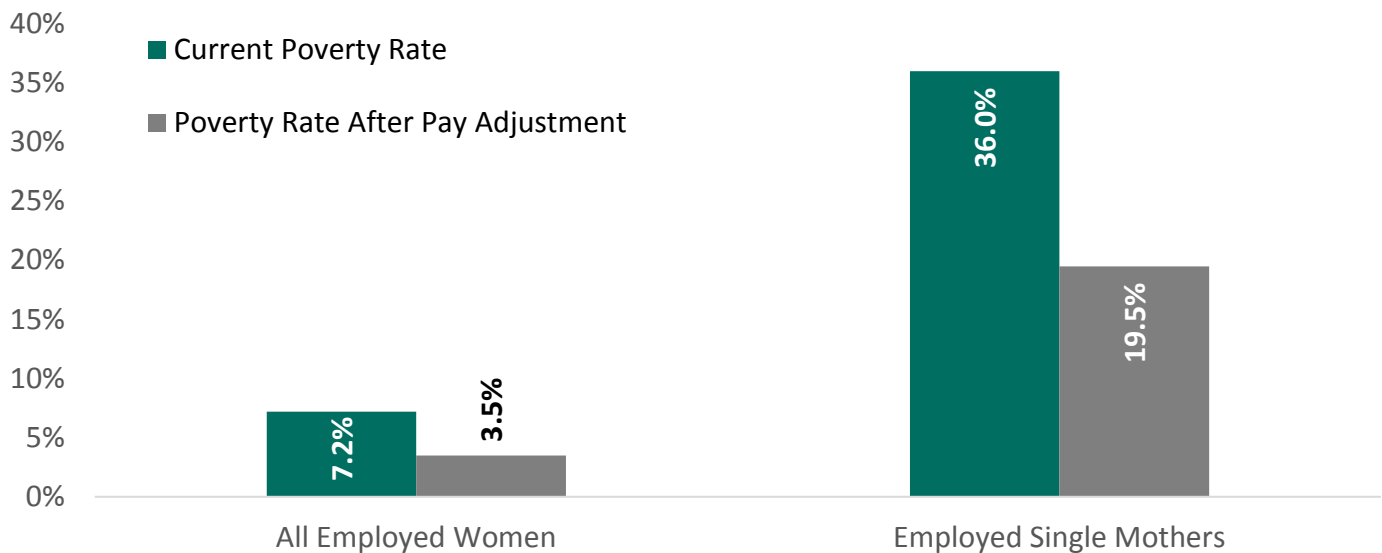

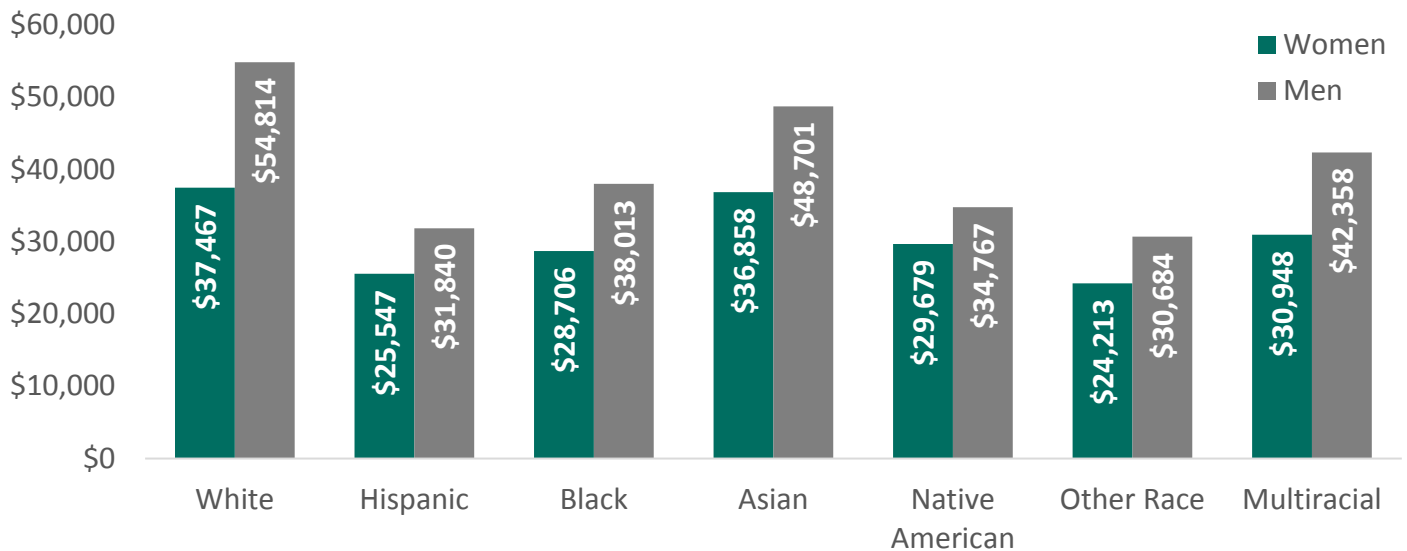

1. Linear projection based on rate of progress in closing the gender wage gap since 1959. Projection is based on the ratio of women's to men's earnings among full-time, year-round workers aged 16 and older. Calculations are based on the Decennial Censuses from 1960 through 2000, and 2001-2015 American Community Survey microdata.
2. The 2015-16 average undergraduate tuition and required fees for in-state, full-time students in degree-granting public two-year institutions in Utah is \$3,569.
3. Comparable includes women and men of the same age and level of education, who work the same number of hours, and have the same urban/rural status.
