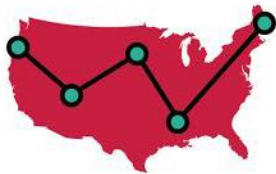

## The Status of Women in Ohio, 2015: Highlights

Women in Ohio have made considerable advances in recent years but still face inequities that often prevent them from reaching their full potential. Since the 2004 *Status of Women in the States* report was published, the gender wage gap in Ohio has narrowed, a higher percentage of women have bachelor's degrees, and women are more likely to work in managerial or professional occupations. Yet, as in all other states, women in Ohio are less likely than men to be in the labor force and more likely to live in poverty. Women also continue to be underrepresented in the state legislature.

### Key Findings

- Ohio's best grades are in the areas of employment and earnings and reproductive rights, for which it receives a C. Its worst grade is in health and well-being, for which it gets a D.
- Ohio women who work full-time, year-round earn 77 cents on the dollar compared with similarly employed men.
- Approximately 28.6 percent of those working in science, technology, engineering, and mathematics (STEM) fields in Ohio are women, compared with 28.8 percent nationwide.
- As of 2015, there are no women of color in statewide elective executive office in Ohio, and only two women of color from the state in the U.S. Congress.
- Women in Ohio who are unionized earn \$175 more per week, on average, than those who are not represented by a union.
- Approximately 25.9 percent of women in Ohio have a bachelor's degree or higher, an increase of about 7 percentage points since 2000.
- In 2012–2013, 19.1 percent of Ohio's four-year-olds were enrolled in state pre-K, preschool special education, or state and federal Head Start.
- Heart disease is the biggest killer of women in the United States. Ohio ranks 39 of 51 with a mortality rate of 150.7 per 100,000.
